From the 12th of April 2022 and pursuant to European regulation 833/2014 (as amended) and European regulation 398/2022 and Council decision 2022/579, subscription of new units and shares of the UCITS listed above (insofar as they may offer exposition to securities denominated in any official currency of a Member-State after the 12<sup>th</sup> of April 2022) shall no longer be permitted:

- To any Russian nationals or natural persons residing in Russia, or legal persons, entities or bodies established in Russia and;
- To any Belarusian nationals or natural persons residing in Belarus, or legal persons, entities or bodies established in Belarus.

As set out in European regulation 833/2014 (as amended) and European regulation 398/2022, the above restrictions shall not be applicable to nationals of a Member State or natural persons having a temporary or permanent residence permit in a Member State

These changes have no impact on the management of the UCITS and their characteristics, which remain unamended. The UCITS' Prospectuses will be modified in accordance with these new restrictions.
